

Title 1 Parent Policy

Part I. GENERAL EXPECTATIONS

The Dibble Public School District agrees to implement the following statutory requirements:

- The school will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consist with section 1118 of the Elementary and Secondary Educational Act (ESEA). Those programs, meaningful consultation with parents of participating children.
- Consistent with section 1118, the school district will work its schools to ensure that the required school-level parental involvement policies meet the requirements of section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- The school district will incorporate this district wide parental involvement policy into its LEA plan developed under section 1112 of the ESEA.

1. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Inviting Parents to "Pack the House" night and other relevant activities.

D. - providing other reasonable support for parental involvement activities under section 1118 as parents may request.
